**Maximum Out of Pocket (MOOP):** Please refer to your medical plan summary for details.

**Specialty Medications:** Specialty medications must be ordered through Caremark Specialty Pharmacy, limited to a 30 day supply and require prior authorization or step therapy for preferred products.

**Generic Policy:** If your doctor writes a prescription stating that a Generic may be dispensed, we will only pay for the Generic drug. If you choose to buy the Brand name drug in this situation, you will be required to pay the Brand co-pay plus the difference in cost between the Generic and Brand name drug. The Generic Policy does not apply if your doctor requires a brand name medication.

#### **DRUGS COVERED\***

- Legend Drugs (drugs that require a prescription) **Exceptions:** See Exclusion list below.
- Compound medications of which at least one ingredient is a legend drug at a participating pharmacy. Compounded medications equal to or exceeding \$300 per script will require prior authorization.
- Contraceptives: Oral, Transdermal, Intravaginal, Implants/IUD and Injectable; extended cycle products are subject to 3x retail copays for a 90 day supply
- Diabetic Care: Insulin/Insulin pre-filled syringes, Agents/Strips, Disposable insulin needles/syringes/lancets
- Prescription Vitamins
- Topical Acne Agents (prior authorization required over age 34)
- Androgens (prior authorization required)
- ADD/ADHD Medications
- Narcolepsy Medications (prior authorization required)
- Oral/Intranasal/Topical Fentanyl Products (prior authorization required)
- Growth Hormones (prior authorization required)
- Migraine medications (quantity limits apply)
- Influenza Agents (quantity limits apply)
- Antiemetics (quantity limits apply)
- Extended Release Controlled Substances-Opioid Analgesics (quantity limits apply)
- Prescription and OTC smoking cessation (two 12 week programs per plan year) OTC requires prescription
- Glumetza/Fortamet and Zegerid (Prior authorization required)

#### **EXCLUSIONS\***

- Biological, blood products, serums, immunoglobulin, and Non-ACA immunization agents
- Cosmetic agents (Anti-wrinkle agents, Depigmenting agents, Hair growth stimulants and removal products)
- Compounded prescriptions that use ingredients such as bulk chemicals, high cost powders, and compound kits
- Topical Analgesic Pain Patches
- Anabolic Steroids
- Infertility Medications
- Impotency Medications
- New to market drugs, including line extensions and new strengths until clinically reviewed
- Anti-obesity/Appetite suppression
- Over the counter (OTC) medications
- Medication which is to be taken by or administered to an individual, in whole or in part, while he or she is a patient in a licensed hospital, rest home, sanitarium, extended care facility, convalescent hospital, nursing home or similar institution which operates on its premises, or allows to be operated on its premises, a facility for dispensing pharmaceuticals.
- Patient assistance programs may not apply to deductible and out of pocket accumulations.
